
## **Nepal: Striving for a Disaster Resilient Nation**



- Natural Calamity (Relief) Act, 1982, MoHA designated as nodal agency for disaster management.
- Disaster Relief Committees at Central, Regional, District and Local levels established
- **Central to Local level Disaster Relief Fund established**
- Large scale public awareness and community based disaster management initiated
- Local bodies made responsible for disaster management as per Local-Self Governance Act, 1999
- **National Building Code developed**
- "National Action Plan on Disaster Management" developed and presented at first world conference on disaster management (WCDM)
- Incorporated disaster management subjects in school curricula and school safety program initiated
- Hospital preparedness programs initiated
- Disaster Preparedness Network (DPNet) established for coordination among government and non-government agencies
- The Prime Minister's Natural Disaster Relief Fund established
- New concept of "Total Disaster Risk Management" initiated
- Disaster management information system initiated
- Aspects of disaster management started to integrate in national development plan (10<sup>th</sup> Five Year Development Plan)
- Guidelines on Emergency Preparedness and Disaster Management for hospital, 2002
- Fifteen-year Sustainable Development Agenda of Nepal (SDAN), 2002-2017
- Water Induced Disaster Management Policy, 2005
- National Strategy on Disaster Risk Management, 2009 endorsed
- Senior officials deputed as DRR and CRM Focal Persons in key agencies,
- Emergency Operation Centers (EOCs) established at national (1), regional (5), and district level (49) Community Based Early Warning System established in the five major river basins linked to EOCs

- National Disaster Response Framework, 2013 endorsed

- Guidance Note on District Disaster Preparedness and Response Planning, 2011 approved and DPRP developed in all districts and updated annually
- **Dead body Management Guidelines, 2013**

- Post Disaster Need Assessment (PDNA) completed
- Earthquake Affected Structures' Reconstruction Related Act, 2072 enacted and National **Reconstruction Authority established**

- **Urban Resilience Strategy and Risk Sensitive Land Use Plan drafted**
