The RFP documents consisting of the technical and financial proposals, duly completed and separately sealed and again enclosed in a sealed envelope, must be submitted and reach MOITFE Gandaki province not later than 15/09/2075/ (maximum 31 days) 12:00 PM. Documents received after this deadline shall not be accepted.
- 3. In case the last day of submission of the RFP falls on a public holiday, it shall be submitted on the following working day.
- 4. All technical proposals received within due date will be opened at 14.00 hrs. of the last day of submission in the presence of the consultant or his representative. However, the absence of the consultant or his representative will not hinder the opening of the proposals.
- 5. The technical proposals will be opened and evaluated first. The financial proposals of those technical proposals securing more than 70% marks will only be opened and evaluated.
- 6. The consulting firm will be selected under the Quality and Cost Based Selection (QCBS). The MOITFE reserves the rights to select or not to select any or all of the Firm(s) without assigning any reasons whatsoever.
- 7. RFP documents must be accompanied by Firm Registration, VAT Registration, and Tax clearance certificate for FY 2074/75, Power of attorney of signatory and JV agreement (if any).
- 8. Proposals received after the due date or found not in order will not be considered.
- 9. Any other matter will be settled as per Public Procurement Act, 2063 and Public Procurement Rules, 2064 of Government of Nepal.
- 10. Interested consultancy firms may obtain further information or clarification from MOITFE during office hours.
- 11. Consultants can submit the proposal for two packages only either singly or in joint venture. Proposal submitted by a consultant singly or in joint venture in more than two packages will be disqualified.
