Electronic Bids must be submitted to the office of *Metropolitan Police Office, Ranipokhari Kathmandu through PPMO website: [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp)* on or before **19 March 2019 (5<sup>th</sup> Chaitra, 2075)** at 12:00 noon. Documents received after this deadline shall not be accepted.

The Bids will be opened in the presence of Bidders' representatives who choose to attend **19 March, 2019 (05<sup>th</sup> Chaitra 2075)** at 14:00 hours at the office of *MPO, Ranipokhari Kathmandu Nepal*. Bids must be valid for a period of **90 days** counting from the day of bid opening and must be accompanied by bid security, which shall be **valid for minimum 30 days** beyond the bid validity period.
