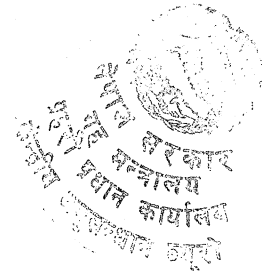

4. Electronic Bids must be submitted to the **Central Investigation Bureau, Maharajjung, Kathmandu through PPMO's website: www.bolpatra.gov.np/egg** on or before **12:00 noon, 15th January, 2020 (1st Magh, 2076)** Documents received after this deadline shall not be accepted.

The Bids will be opened in the presence of Bidders' representatives who choose to **15th January, 2020 (1st Magh, 2076)** at 14:00 hours at **Central Investigation Bureau, Maharajjung, Kathmandu, Nepal**. Bids must be valid for a period of **90 days** counting from the day of bid opening and must be accompanied by bid security, which shall be **valid for minimum 30 days** beyond the bid validity period.
6. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such case the bid validity and bid security shall remain the same as specified for the original last date of bid submission.
