
In Article 35 of the Constitution of Nepal, every citizen shall have the right to receive basic health services free of charge from the state as provided by law and no one shall be deprived of emergency health services. The constitution has also guaranteed senior citizens the right to special protection and social security from the state. An equitable and inclusive health system is a Government priority and is reflected in the National Health Policy, 2019, the Fifteenth Plan (2019/20 to 2024/25) and the Gender Equality and Social Inclusion (GESI) Strategy of the Health Sector. These policies provide for improving the access of senior citizens to quality health services and strengthening health service delivery to be inclusive and responsive to the needs of senior citizens.

Geriatric health service strategy 2078/79-2087/88 provides direction and accountability for improving health services for the aged in Nepal. It recognizes that senior citizens face increased risk of chronic conditions and multi-morbidities, with reduced functional capacity, and that health services have to account for these limitations and needs. It sets out a comprehensive framework for planning, funding, and providing health care and health protection services to the elderly. The strategy encompasses population-based and service

delivery strategies for healthy aging and covers prevention, resilience building and primary health care, living well with long-term health conditions, better support for senior citizens with high and complex health needs, and improving recovery and rehabilitation from acute episodes. The strategy prioritizes, guides, and sets standards for geriatric health services. It mainstreams geriatric health issues in the national health system, allocates accountability, and recognizes that adaptation of the strategy will be required at provincial and local levels to be relevant and effective. In recognition of the vulnerability and rights of senior citizens, the Ministry of Health and Population decided to develop a Geriatric Health Service Strategy. The Ministry has enforced this strategy following the powers entrusted to the Ministry by the Government of Nepal.

Background

The Ministry of Health and Population, by the spirit of the constitution, has been expanding the establishment and operation of senior citizen wards/services in hospitals to provide free and subsidized health services to senior citizens in every state. MoHP has started the concept of a




Trend on Inter Governmental Fiscal Transfer, including health sector (federal)



Social Service Unit (SSU)

Article 35 of the Constitution of Nepal states that every citizen shall have the right to receive basic health services free of charge as provided by law and no one shall be deprived of emergency health services. Given the spirit of the constitution, the government has implemented the free National Health Service program to provide free or subsidized inpatient, outpatient, and emergency health services to the patients of the target groups. Social Service Unit was established in fiscal year 2065/66 in central, regional, sub-regional and zonal hospitals. In federal and provincial level hospitals, the MOHP has provided a conditional budget, and free medicines.

The hospitals have been providing services according to the SSU establishment and operation guideline,2078. The objective of the SSU is to effectively facilitate and coordinate with hospital staff to provide free and partially free health care services to the target group (poor and ultra, helpless, people with disabilities, geriatric population, GBV survivors, emergency patient.
