One Year On after Launch of MCC Nepal Compact

Millennium Challenge Account-Nepal (MCA-Nepal) marked the first anniversary of the launch of the MCC Nepal Compact since its Entry into Force on 30 August 2023.

Some major highlights are the award of high-value contracts to construct three 400kV substations and the 18km cross-

border electricity transmission line along with contract awards in power sector technical assistance to enable the Electricity Regulatory Commission (ERC) with embedded advisory support and consultancy services to enhance electricity use in affected areas of the Electricity Transmission Project (ETP).

Contract Award for 18km Cross-Border Transmission Line



MCA-Nepal signed a contract, valued at USD 12.36 million, for the construction of the 18km cross-border electricity transmission line (TL) with Transrail Lighting Ltd. on 30 August 2024. The contractor will construct the TL from the 400kV New Butwal Substation in

Nawalparasi (Bardhaghat Susta West) to the Nepal-India border within the contract duration of 21 months.

The 40th MCA-Nepal Board meeting, held on 6 March 2024, decided to advance the 18km Nepal portion of the Butwal-

Gorakhpur power TL on a priority basis by separating it from the larger 315km TL to meet the obligations of the cross-border power trade agreement between the governments of Nepal and India.

The 18 km transmission line will play an important role in helping Nepal make strides in achieving its domestic power goals and reinforcing Nepal's position in the regional energy market. The transmission line infrastructure will also promote investment in hydropower projects in Nepal and facilitate additional power trade between Nepal and India through the New Butwal – Gorakhpur, India cross-border line.

Contract Award for Ratmate Substation

MCA-Nepal signed a contract, valued at USD 51.6 million, to construct a 400kV Substation at Ratmate in Nuwakot district with Techno Electric and Engineering Company Ltd., India on 14 June 2024. The 400kV GIS substation will be constructed within the contract duration of 39 months.

The substation will serve as a critical interconnection of power transmission between the Lapsiphedi and New Hetauda Substations. Once completed, Ratmate Substation will have a capacity of 1000 MVA making it one of the largest substations in the country.

MCA-Nepal signed а USD contract, valued at 35.31 million, for construction of the New Butwal Substation Linxon India Pvt. Ltd. in an event in Nawalparasi (Bardaghat Susta West) district in Lumbini Province on 9 May 2024.

The 400kV Gas Insulated Switchgear (GIS) substation will be constructed within the contract duration of 39 months and will have a capacity of 945 MVA.

Contract Award for New Damauli Substation

MCA-Nepal signed USD contract, valued at 38.89 million, for the construction of the 400kV New Damauli Substation in Tanahun district with Techno and Engineering Company Ltd. (TEECL) on 31 July 2024. The contractor will construct the substation within the contract duration of 39 months.

Once completed, the New Damauli Substation will have a capacity of 1000 Mega Volt Ampere (MVA), making it one of the largest substations in the country along with the Ratmate Substation. The New Damauli Substation will be a critical connection point for power flow with the Ratmate Substation, Lekhnath Substation and New Butwal Substation.

Contract Award for Capacity Building Activities to Enhance Electricity Use



MCA-Nepal signed a USD 2.4 million contract under the MCA Partnership Program of the ETP with Winrock International Institute for Agricultural Development on 22 July 2024. The contract will provide consultancy services for Capacity Building Activities to Enhance Electricity Use. It will be executed within the contract period of 36 months.

The consultant will support MCA-Nepal enhance the capacity of institutions and individuals with a focus on preparing Municipal Energy Plans and developing capacities for the productive use of electricity within affected wards of the ETP.

ELECTRICITY TRANSMISSION PROJECT

Market Outreach for 297 km Transmission Line

MCA-Nepal organized a market outreach event in Kathmandu for the upcoming procurement of the remaining 297 km of transmission on 30 September 2024. 70 participants representing various national and international companies attended the event that provided detailed information on the scope of work, timeline, procurement procedures, principles, and guidelines of MCA-Nepal to potential bidders. The bid for the 297 km transmission line will be launched in November 2024. MCA-Nepal has already contracted out 18km cross-border critical transmission line following priority procurement separate process. The 18km transmission line was separated from the larger 315 km transmission line following a collaborative decision given its significance of cross-border trade for the Government of Nepal.

Study of Temporary Access Tracks for 297km of TL

MCA-Nepal has completed an engineering survey on temporary access tracks required for the construction of tower pads along the route of the transmission line (TL) to be built under the ETP. The survey carried out in eight districts was completed on 25 April 2024. Additionally, an environmental and social assessment survey for selected temporary access tracks in the eight districts was also carried out and completed in August 2024.

The survey has provided detailed field data on the length of the temporary access tracks and their environmental and social impact. This has been incorporated in the revised bid document for the remaining 297km TL.

Closure of Ratmate Livelihood Restoration Program (LRP)

MCA-Nepal has completed the Ratmate Livelihood Restoration Program (LRP) implementation, initiated on 18 March 2022 with the support of its Consultant SAPPROS Nepal, on 30 May 2024. The LRP was launched to restore or improve the livelihoods of around 270 Project-Affected Persons (PAPs) whose land was acquired in the Ratmate area of Nuwakot district.

The two-year program executed a variety of interventions including agricultural advancement activities, skills-based training, financial literacy, GSI and life skills orientations, adult literacy training, business plan development and the establishment of a multipurpose cooperative.

The LRP trained 106 PAPs under agriculture advancement activities such as commercial vegetable farming, goat farming, poultry farming, and rice farming. The PAPs were provided with required input and technical support after the trainings which resulted in increased productivity by 303 %. Similarly, 163 PAPs participated in 18 different trades under the



skills-based training component of the LRP.

Financial literacy, adult literacy, GSI and life-skills orientations were also provided to PAPs. These trainings have enabled PAPs to manage their finances and encouraged savings and entrepreneurship. The first Cooperative in Belkotgadhi Municipality was also registered on 10 May 2023 as a hallmark of the program for access to savings and credit.

Overall, the LRP enhanced agricultural productivity leading to increased income levels. and skills development improved employability. As an outcome, 34 **PAPs** have secured jobs and 39 have initiated their own businesses.

MCA-Nepal organized an event on 23 July 2024 to appreciate its Consultant SAPPROS Nepal on the successful implementation of the Ratmate LRP.

PROGRESS IN SITE ACCESS

Land Acquisition for Transmission Lines

MCA-Nepal has made notable progress in acquiring land to build tower pads for the transmission line (TL) in all ETP-affected districts. As per Section 9 of the Land Acquisition Act,

1977, public notices with full details of the land parcels to be acquired were issued in all nine districts. Post the publication of the notice, Compensation Fixation Committee (CFC)

Sub-committees formed to recommend compensation rates for the lands to be acquired have completed field verification visits in all nine districts.

Compensation Rates of Land determined in Five Districts

Compensation rates of land to be acquired for the construction of TL tower pads under the ETP have been determined in Five districts.

The Compensation Fixation Committees (CFCs) formed as per the Land Acquisition Act, 1977 and chaired by the Chief District Officer (CDO) of respective districts determined the compensation rates after the completion of the required process and mandatory

activities and in consultations with relevant stakeholders.

Compensation rates of land to be acquired for the construction of TL tower pads under the ETP were determined in Chitwan on 13 September, in Tanahun on 11 September, in Nawalparasi (Bardaghat Susta West) on 7 July, in Makwanpur district on 10 May and in Dhading district on 30 April 2024.

Similarly, CFCs formed in other

districts will be determining compensation rates for land in the coming months.

Earlier, MCA-Nepal organized field visits for subcommittees, formed under the CFCs and led by Assistant Chief Officers District these of districts to recommend the compensation for land. Officials from related government agencies alongside elected representatives were part of the visit.

ROAD MAINTENANCE PROJECT

Initial IEE Report for FDR Works approved

The Initial Environmental Examination (IEE) report prepared for the 40km Full Depth Reclamation (FDR) road maintenance works from Dhankhola to the Lamahi segment of the East-West Highway has been approved by the Ministry of Physical Infrastructure and Transport (MoPIT) on 18 August 2024.

A discussion meeting was organized earlier on 2 June 2024 with various stakeholders before it was submitted to the Ministry for approval.

The report will help MCA-Nepal adopt measures to reduce the negative impact of the project on the environment and the community.

SUCCESS STORY

Bhimeshwar Multiple Cooperative Ltd. - Creating Economic Opportunities

One of the key components of the Ratmate Livelihood Restoration Program (LRP), designed by MCA-Nepal to restore the livelihood of project-affected people at Ratmate, was setting up a cooperative to mobilize savings and credits to support agricultural activities and income-generating businesses for project-affected families.

With and the support technical guidance of MCA-Nepal Consultant **SAPPROS** Multiple Nepal. Bhimeshwar Cooperative Limited, established in Belkotgadhi Municipality in Nuwakot district, was registered on 10 May 2024. Trainings on account keeping, cooperative management, governance, saving and credit mobilization, financial lending and reimbursement of loans as well as market linkage of agricultural products were also provided to enhance the capacity of members.

Mr. Maheshwor Neupane, the

Chairperson of the Cooperative and a project-affected person shared, "The cooperative will foster a sense of solidarity and mutual support among members, promoting social cohesion and resilience in the face of challenges. It will also serve as platforms for skillbuilding, knowledge-sharing, and capacity development, project-affected empowering families to pursue sustainable livelihoods and achieve longterm economic stability.'

Ms. Sanju Bagale, the Team Leader for the LRP, SAPPROs Nepal, shared, "In the course of the registration of the cooperative, a major obstacle was the absence of bylaws necessary to register a cooperative in Belkotgadhi municipality. The LRP team had to facilitate the process of endorsing the bylaws simultaneously conduct various key activities to establish the same after relentless efforts."



The cooperative was officially inaugurated by the Mayor of Belkotgadhi Municipality on 4 July 2023. As of the closing of the LRP program, the cooperative already generated a total revenue of NPR 12,228,700 from the shareholding members and provided 34 individuals with loans to initiate their own small-scale businesses or scale up the existing businesses among which 16 are project-affected persons.
