### 2. PRELIMINARY

- 2.1. The meeting of the Board of Directors was duly constituted on 8 February 2019 (2075/10/25 BS) after the notice was served in writing on 5 February 2019 (2075/10/22 BS).
- 2.2. The Chairperson welcomed all the members of the Board of Directors and other invitees attending the meeting.
- 2.3. The Chairperson reported that a quorum was present in accordance with Millennium Challenge Account Nepal Development Board Formation Order, 2074 (2018).
- 2.4. Semanta Dahal, Legal Advisor, Millennium Challenge Account-Nepal presented the agenda to the MCA-Nepal Board of Directors.

### 3. UPDATE ABOUT BUTUWAL-GORAKHPUR CROSS-BORDER TRANSMISSION LINE

Mr. Nabin Raj Singh, Member of MCA-Nepal Board of Directors (and, Joint Secretary, Ministry of Energy, Water Resources and Irrigation) briefed the MCA-Nepal Board about the recent meeting of Join Working Group (held on 23 January 2019) and Joint Steering Committee (held on 24 January 2019) on Nepal India Power Cooperation. Mr. Singh circulated the minutes of the meeting of Joint Steering Committee for information. Mr. Singh further informed the MCA-Nepal Board that Nepal Electricity Authority (NEA) and Central Electricity Authority (India) would examine the funding and implementation options for Indian portion of the New Butwal-Gorakhpur Transmission Line within next three months.

# 4.1. Agenda One: Appointment of Deputy Executive Director-Management of Millennium Challenge Account-Nepal

Subject to MCC's no-objection process, the Board of Directors has decided to appoint Ms. Shalini Tripathi as Deputy Executive Director-Management of MCA-Nepal for a period of two (2) years effective from the signing of the Employment Agreement.

# 4.2. Agenda Two: Approval for Salary Negotiations with the Mr. Hitendra Dev Shakya, Candidate for Deputy Executive Director-Project Delivery

The Board of Directors has decided to approve the appointment of Mr. Hitendra Dev Shakya as Deputy Executive Director-Project Delivery of MCA-Nepal only after successful salary negotiations and resignation from Nepal Electricity Authority.
