AGREEMENT
BETWEEN

HIS MAJESTY'S GOVERNMENT OF NEPAL
AND

THE GOVERNMENT OF THE REPUBLIC OF FRANCE
relating to a grant of food aid

His Majesty's Government of Nepal and the Government of the French Republic have agreed on the following:

ARTICLE 1

The Government of the French Republic shall deliver THREE THOUSAND (3000) metric tons of wheat to His Majesty's Government of Nepal.

ARTICLE 2

The Government of the French Republic shall perform all operations preliminary to the delivery of these supplies which shall also be transported through the good offices and at the own expense of the French Government to RAXAUL.

ARTICLE 3

The above mentioned goods will be available for shipment from the first of August 1988 in a french port.

ARTICLE 4

His Majesty's Government of Nepal shall become owner of the supplies delivered in application of the present agreement from their loading on the carrier ship.

The goods shall be transported on a French shipment and insured by a French insurance company.

ARTICLE 5

The goods delivered shall meet the specification of the european standard of quality.

Their selling value shall be estimated for the purposes of the present agreement at 700 FF per metric ton.

ARTICLE 6

The receiving country shall take the necessary steps to avoid the re-exportation of the goods received or their byproducts similar products.

ARTICLE 7

The contracting parties shall take the necessary steps to make sure that these goods are supplied as a complement to and not a substitution for any commercial transactions which could reasonably be expected to take place in the absence of such aid.

ARTICLE 8

The Government of the French Republic shall request no payment for the goods delivered pursuant to this Agreement.

ARTICLE 9

His Majesty's Government of Nepal shall sell on the nepali's domestic market at the price fixed by the Nepal Food Corporation, the wheat received in application of the present protocol to help bear the cost of the internal transportation of the above referred goods.

ARTICLE 10

The present agreement will come into effect one month after the date of signature, subject to the prior fulfilment of the consultation procedures provided in resolution 1/53 and 2/55 of the Food and Agriculture Organization.

The technical procedures for implementing this aid, as drawn up by the "Office National Interprofessionnel des Cereales" the organization in charge of implementing the aid, are appended to
